Noriega Named



The Texas ESGR Committee is pleased to announce retired **General Richard J. (Rick) Noriega** has been appointed as the next **Texas ESGR Committee Chair**. (Employer Support of the Guard and Reserve) He will assume his duties on October 1, 2024 replacing **David Blackberry**, who is completing his second and final three-year term as the **Texas ESGR** state chair.

ESGR, a Department of Defense office, was established in 1972 to promote cooperation and understanding between Reserve Component Service members and their civilian employers and to assist in the resolution of conflicts arising from an employee's military commitment.

Noriega, a native Houstonian, is a veteran of the **U.S. Army Reserves** and **Army National Guard**. His assignments during his 37 years of service included: **Assistant Division Commander-Support** for the **36th Infantry Division, Texas Army National Guard**; **Laredo Border Sector Commander Operation Jump Start**; **Garrison Commander** for the **Kabul Military Training Center, Afghanistan**; **Commander 71st Information Operations Brigade**; and **Commander 1-141 Infantry Battalion 'First Texas'**.

He retired as the **Assistant**

Adjutant General for the **Texas Army National Guard**, in 2018, and was promoted to **Major General** (Brevet).

Noriega earned a bachelor's degree in communication from the **University of Houston** and a master's degree in public administration from the **John F. Kennedy School of Government, Harvard University**.



Diego Pavia Leads Vanderbilt in Upset of Alabama

It wasn't supposed to happen. Underdog football team, in this case **Vanderbilt University Commodores**, defeats the legendary **Alabama Crimson Tide**, 40 to 35 in Nashville.

Alabama, ranked Number 1 in the college football polls was defeated by unranked **Vanderbilt** for the first time in 40 years. And not only did **Vanderbilt** beat **Alabama**, it did with a quarterback no one thought was good enough to play football in the **South East Conference**.

Diego Pavia, a Mexican American from **Albuquerque, New Mexico**, grew up with 13 brothers and a sister. Their mother, **Antoinetta Padilla** would tell her children, "If want something, you work for it!"

Times were tough for the family and **Diego** said that it was not until he was older did he come to realize that when his mother was not hungry at dinner time, it was because she wanted to make sure the kids had enough to eat.

After high school, **Diego** was a bit disappointed that there were not more offers from college football coaches. He did attend

the **New Mexico Military Institute** and later transferred to **New Mexico State** to play football. When **Vanderbilt** was looking for an **Offensive Coordinator** they went to **New Mexico State** and spoke with **Pavia's** coach who took the job at **Vanderbilt** and also took **Pavia** with him to **Nashville**. And it was here that **Diego Pavia** has now become a sensation. We expect to hear about this young man.

On the Passing of Little Joe's Wife



The Tejano music community mourns the loss of **Criselda Cantu Hernandez**, the beloved wife of music legend **Little Joe**, who passed away at the age of 86. The sad news was announced in a heartfelt statement shared by **Little Joe Y La Familia**, expressing their deep sorrow and broken hearts.

"It is with our deepest sorrows and broken hearts that we share the news of La Familia's First Lady Criselda Cantu Hernandez making her ascent into heaven on Thursday, October 10, 2024. At her time of passing, she was entirely surrounded by her family at home," the statement read.

Joe and **Cris** shared an extraordinary journey together, spending 69 years as a couple, with 62 of those years as husband and wife. **Criselda** was a pivotal figure in the Tejano music industry. She served as the president of **Leona Records** and co-founded **DeLeon Publishing**. Alongside **Joe**, she co-founded **Little Joe and The Latinaires**, which later became **Little Joe Y La Familia**. In the early days of **Joe's** career, **Cris** played a crucial role as a costumer and seamstress, creating outfits for **Joe** and the band.

A recent viral video clip of **Little Joe** at the **Festival Chicano** in **Houston, Texas** on October 4, showed the 83-year-old singer foreshadowing this sad news. He said, "I've been, well, let's just say, distracted. A lot of things are going on in my life that I have to confront, and I will have to make a big difficult decision not too long from now. And I try to clear my mind of it but it's there because it's the inevitable and it's going to change my life. Pero con el favor de Dios and your support I'll get over it."



Mexico's New President Claudia Sheinbaum

Claudia Sheinbaum is taking the media by storm as she becomes the first female president the country of **Mexico** has ever seen. She was elected on June 3rd, with 50-60% of the public vote, and took office on October 1st. Along with her extensive political resume, such as being the former Mayor of **Mexico City**, **Sheinbaum** is an environmental engineer with a doctorate and has dedicated her life to scientific findings on sustainability and helping the environment.

Born in **Mexico City**, her advocacy in her mother country started early in the 80's. She received her education from the **National Autonomous University of Mexico** and worked at **University of California-Berkeley**.

She is the first president Jewish background in a country that is predominantly Catholic. She takes the place of **Andres Lopez**, with his blessing, and promises her country that she has nothing but the best intentions for her people. Millions of Mexican

citizens gathered to show their support, and acknowledge the importance of a female elected official in a country that has always been male dominated.

Dr. Sheinbaum has proven efficient as she has already begun appointing her cabinet. Despite differing opinions on the future President, it is undeniable the impact she has made on the country as we all watch what is to come from her presidency.

Jonny Garza Villa



The Growing Popularity in 20 South Texas

The citizens of **Texas** have had five (5) opportunities to vote for **Donald J. Trump** for **President of the United States**. They did so twice in 2016, twice in 2020 and thus far once in the March Primary of this year.

In the **Republic Primary** election on March 1st, 2016, **Donald Trump** received 758,762 votes statewide. **Ted Cruz**, the junior senator, also ran for President and received, 1,241,118 votes statewide. **La Voz Newspaper** examined 20 counties in **South Texas** primarily along the border and found that in 2016, **Ted Cruz** received more votes than **Donald Trump** in every county except **Webb** and **Zapata**. A total of 14 Republican candidates were on the Republican ballot in 2016, and **Donald Trump** went on to become the 45th **President of the United States**.

Fast Forward to 2024 Presidential Election

Now in 2024, **Donald Trump** is attempting a political come back. And when one travels throughout these 20 **South Texas** border counties and sees all the **Trump** signs and hears about the "**Trump Trains**" (caravans that roam highways with **Trump** regalia), the question is why is **Donald Trump** so popular in this part of the state?

Trump's Strong Appeal Among Hispanic Voters

The **Rasmussen** poll, released on October 7, 2024, reveals that **Trump's** popularity with **Hispanic** voters has surged to an unexpected level, particularly given the historical trend of this group favoring **Democratic** candidates. The 62% support for **Trump** represents a dramatic shift, considering the close race between **Trump** and **Hispanic** voters in previous elections.

Political analysts have pointed out that **Trump's** economic policies, particularly those focused on job creation, tax cuts, and his stance on border security, might be key reasons behind this boost.

Despite **Trump's** controversial comments on immigration in the past, his ability to tap into the economic concerns of **Hispanic** voters may have played a crucial role in this significant lead.

The tables below shows how **Donald Trump** has fared in the 20 counties we looked at. Many of these counties are heavily Hispanic. In every county, from **Atascosa** to **Zavala County**, home of the **Raza Unida Party**, **Donald Trump** has doubled and in some cases tripled the number of votes he has received since he first ran in 2016. And it is not just **Trump** who is getting large numbers of voters, it is also **Ted Cruz** who is benefiting. Is it fair to say that **South Texas** has gone **Republican**? On November 5th, 2024, the voters will answer this question.


of Donald Trump Border Counties

There are plenty of activists who have complained about the absence of the **Democratic Party, The Texas Democratic Party** and the lack of resources to educate and get out the vote among **Texas Hispanics**. Carmen Llanes Pulido has been a community activist all of her adult life. She has worked with **PODER**, served on numerous city commissions and boards and is currently the **Executive Director** of **GAVA** (Go AustinVamos Austin) She is now running for **Mayor of Austin** and shares some of her thoughts with **Skylar Bonilla** who conducted this interview a few months ago for **La Voz Newspapers**

La Voz: Tell us about your campaign—**Carmen**, why are you running for **Mayor of Austin** in 2024?

Carmen: The protagonist in my story is the people of **Austin** and all the issues they care about. I've spent my whole adult life working on issues with people and it's always been about people. It's been about the issues for our communities.

La Voz: What are the core values of your campaign? Name three core values.

Carmen: Number one is accountability because there is a large base that has supported me to get to this point and to whom I am accountable. These are very diverse communities across **Austin** of all different incomes and backgrounds, from all different kinds of neighborhoods in different parts of town. But in particular, I pay attention to issues that impact the working-class and people who don't have a ton of disposable income in the city because that's who's been the backbone of this place for a long time. And so, actually knowing those folks means something to me. This is not about a political career. This is about outcomes for those folks. So, accountability is really big.

Transparency is also really important. Being able to look at the dollars that we've invested into our city: the taxing, the bonds, the tax increases, the in-

creases in rent. Where is all that money going? Our public utilities belong to us as rate payers in the city.

So transparency about our funding is really important. And inclusivity, you know, community engagement, is a hugely important principle and value in this campaign. This is a people power campaign. This is also a move for people-powered governance, for people-powered municipal oversight, for engagement of content experts, who are our technical experts and people with lived expertise in all of our neighborhoods, to address our infrastructure, basic services, affordability in housing and to take care of our parks and green spaces. These are all things that we can engage the public to address and there's a part for everybody to play in that. There's a part for everybody to play in this campaign and that's been really fun.

La Voz: You've done so much work—working on the **Independent Citizens Redistricting Committee** and you were able to be engaged with all different ethnicities and backgrounds and social classes that make up our great community. What are the biggest lessons that you learned about navigating those social dynamics between Natives and newcomers?

Carmen: I don't think there's inherently a tension between those two groups. A lot of times we perceive that because of the tension of growth in our city and the way that some communities become exclusive; whether we intend for them to or not. And so, what I've learned is that navigating that you meet everybody where they're at and it's really important to value and learn from history and share culture.

Everybody has something to contrib-

ute. Whether you know what this neighborhood looked like 30 years ago and have four generations here. You have like a ton of wisdom to bring to a conversation about where the community is headed. You may be a refugee from another country, but you have thousands of years of culture to pull up on to share with the people who are now your neighbors and that is a source of strength.

So we're seeing that in my organization **GAVA**, we're starting the creation of a community-owned grocery cooperative where we have a steering committee made up of multi-generational East Austinites, immigrants from **Central America** who have been here a generation raising their kids, and includes refugees from far away countries who speak multiple languages who are connected to people in often isolated communities in **Austin** because there is no language service or other direct services for them.

Having those voices included in the conversation takes more time and resources. It takes patience. It takes ded-

ication to those relationships, but the results you get are beyond imagination. The kind of skills that you can combine and how far you can go with that and the energy it attracts...I mean people are really excited when they hear about this multicultural-cooperative grocery service that's going to come. We're going to make it happen against all odds. It'll be "For Us, By Us" for those of us who remember FUBU. This is something that comes out of the needs and desires of people who have been the most marginalized and because of that it's going to benefit everybody.

La Voz: How does that translate to future policy as mayor?

Carmen: Take Public Transit, if we actually make **Cap Metro** work the

best that it can work for the thirty-thousand people who take it every day then everybody is going to want to use it; even if they don't have to. That's an equity model, but I know Republicans who agree with that logic because they know what it's like for folks on the margin who are not getting the services they want. At the end of the day all of us want a better quality of life. It takes more time and resources to bring people to the table, but the results are way better and they save us money.

La Voz: Why do you think so many old **East Austin** businesses and generational families support the current mayor in his reelection? What new perspective can you offer them?

Carmen: You know, you can't underestimate nostalgia and relationships. I mean we have a mayor who was mayor twenty plus years ago. He knows about the good-old-days, right? He's had relationships with people for a really long time. Some of the same ones I've had relationships with for a really long time too except when he was mayor the first time I was just becoming a young

adult. I've had my whole adult life to watch the outcomes of his policies, and so have they. But maybe folks haven't paid attention to what he's been doing now versus what he did twenty years ago. It's also hard to believe that someone we've supported in the past would do things that harm our communities.

La Voz: What direct harm have you seen done to our community?

Carmen: The deal making and decisions made without consulting people has caused direct harm. Bringing in the **Texas Department of Public Safety** because of people concerned about crime is legitimate, but we know that policing doesn't work the same on every side of town. And there were one thousand people pulled over who did not receive a citation at the very beginning of **DPS** coming in. Those are people pulled over for no real reason. And do you know that The **City of Austin** just gave the **Austin Police Department** \$4 million with no expectation... or any metrics at all and that we can never get that money back?

And do you know that he (Watson)

just voted for the largest upzoning and mass gentrification causing an increase in land development potential for the whole city? Do you realize that he brought back **CodeNext** on steroids? I would ask those old **Austin** institutions, are people happy with **Saltillo Plaza**? Are people even aware of what is happening in our city governance right now?

I think it's just a question of awareness: are people aware of what's actually happening to our neighborhoods and what's happening in our city government right now? I've heard a lot of people say well I've known him for so long. Well, just because we've known him for so long doesn't necessarily mean that he needs to be mayor anymore.

La Voz: So, what is your vision for **Austin** in 20 years? Looking back at your time as mayor 20 years from now, what do you see?

Carmen: We still have an urban canopy and we still have some beautiful parks and green spaces. We still have working-class people in **Austin**. We have a mix of different types of people. We are still drawing in cool new people to Austin who want to study here, who want to work here and who want to raise a family here. We have kids and elders in the city. We have real Transit options, and we're not polluting so much.

We have better buildings that aren't losing energy. We have electric vehicles that are polluting the Earth less. We just have some better air quality because we're not dealing with fossil fuel traffic congestion anymore. In 20 years we've kept our utility- our publicly owned Austin Energy and publicly owned Austin Water-and we're

not invested in fossil fuels anymore. We're out of Fayette Coal Plant. We've got solar batteries all over the city. We got regeneration and backup power for communities for when there are power outages. Hopefully, we're not dealing with power outages anymore in 20 years. Hopefully, we've secured our grid but we'll have backup and we'll have systems that get us through the heat waves and the floods.

It's not going to be an easy few decades ahead of us. But if we're smart we'll have a water supply because we'll have dual piping and we'll be pulling the condensation out of the air and using that water to flush our toilets and water our plants. We'll be saving our rainwater so we still have water here in twenty years. All that is going to require good planning for our growth and better deal making for our public and not giving too much away when people want to make money here.

La Voz: **Carmen** you say that you are progressive, what does that mean?

Carmen: I'm glad you asked because I really think it's important that we know that we know what we mean by that right? When it comes to economics, we're talking a lot about economic and social equity, racial equity. We're recognizing that economic hits and wins don't hit all our communities the same way. We look at where things are and make them better. And if we can make life better for people on the margin, we improve quality of life where it's needed most, then everyone benefits. That's what we mean by progressive.

If people can afford to be creative here and can afford to engage in activities besides just work, then actually we produce culture. We produce all kinds of things that make people want to come to Austin.

The City received a petition certified as sufficient by the City Clerk on July 23, 2024, regarding property consisting of 35 lots on 96.9 acres of land on Menchaca Road south of Slaughter Lane (the Area), requesting the release of the Area from the City's extraterritorial jurisdiction (ETJ) and into unincorporated Travis County; a map of the Area is included in Exhibit M, attached and incorporated as a part of this ordinance.

Pursuant to the petition and Section 42.153 of the Texas Local Government Code, Council orders a special municipal election to be held in the Area on November 5, 2024, to submit to the voters of the Area the question of whether to release the Area from the ETJ of the City.

Only the registered voters of the Area may vote on the issue of releasing it from the City's ETJ. In addition to containing any other ballot items or propositions on which they are entitled to vote, the ballot for voters in the Area shall be prepared to permit voting "Yes" or "No" (or "For" or "Against") on the following proposition:

Proposition P: Shall an untaxed area in the City of Austin's extraterritorial jurisdiction, containing 35 lots on approximately 96.9 acres of land on Menchaca Road south of Slaughter Lane, be released from the City of Austin's extraterritorial jurisdiction and into unincorporated Travis County, with the result that the Area will no longer be governed by the City's environmental and development regulations?



